II. NARRATIVE

Besides providing direct services to farmworkers, Community Action Organization is involved in:

- <u>Collaborations</u>: Working with other service providers to plan, coordinate and implement programs serving farmworkers;
- <u>Community Organizing and Education</u>: Identifying and meeting with groups of farmworkers to achieve an identified result;
- Planning: In partnership with other providers, and with all WCCAO departments, identifying needs, resources available, and gaps in services;
- <u>Networking</u>: Communicating, meeting, providing linkages and support to other groups and agencies serving farmworkers;
- <u>Leadership Building:</u> Working with identified groups of farmworkers to provide training and support for self-advocacy.

This includes the following accomplishments from July 1, 1993 through December 31, 1994:

- Executive Director meets monthly with volunteers and service providers to discuss issues related to serving farmworkers and to develop common goals;
- Executive Director serves as The Chair of the Virginia Garcia Memorial Health Center Board; primary clientele of VGMHC are farmworkers;
- Client Services staff participates in monthly meetings with Hispanic Family Services Coalition;
- Farmworker Outreach Specialist chairs PACTO Migrant Camp Outreach Project, a collaboration to coordinate services to camps with churches and agencies;
- Staff support provided to the Housing Development Corporation to plan and build farmworker housing;
- Designation of CAO by Washington County government in their Emergency Plan as the lead agency for responding to food and shelter needs of migrants during times of high influx;
- Partnership to plan and coordinate the Hispanic Family Resource Center, located at middle school in Forest Grove: Partnership with Washington County Aging Services to identify elderly farmworkers and help them access services;

- Coordination with Adult and Family Services to provide outstation for Food Stamps for migrant workers;
- Membership on CASA Board of Directors, providing technical assistance and support for farmworker housing development and management;
- Subcontracts with other agencies to provide food for migrant emergency food boxes, outreach to Hispanic victims of domestic violence, bilingual support for tenants' legal issues;
- Coordination with Migrant Head Start to recruit and transition migrant children into CAO Head Start programs;
- Provided outreach, needs assessments and education on energy and safety issues in conjunction with weatherization of a 50-unit apartment building inhabited primarily by farmworkers;
- Provided outreach, needs assessments and education on energy and safety issues in conjunction with weatherization of 19 units of housing inhabited by farmworkers.
- Took lead in Washington County for statewide farmworker needs assessment;
- Developed proposal to CDBG for Farmworker Outreach/Advocate position which will be funded in 1995-96;
- Developed and distributed special I&R materials for migrant camps;
- Coordinated group in Washington County to investigate need for farmworker credit union; surveyed farmworkers regarding their need for and use of financial services;
- Organized Christmas Party to bring together Tuality Hospital staff and local farmworker families and their children; organized gift giving for families in migrant camp with Forest Grove Elks Club;
- Organized Community meeting in response to rising gang violence among Hispanics and Washington County's first gang-related death; this led to the formation of Familias Unidas which sponsored: Cornelius Clean-Up, Community Forums on Youth and Family Day at Shute Park in Hillsboro. (see attached article)
- Helped to plan Parents Day event held in April at Centro Cultural in Cornelius. This event was attended by over 300 people.
- Helping to plan Migrant Information Forum to be held simultaneously with Parents Day event.
- Obtained preapplication approval for FMHA 514/516 farmworker housing project in Reedville.
- Obtained funds from County Office of Community Development to conduct a feasibility study on reconstructing Campo Azul, a 60 unit seasonal farm labor camp.



United Families help stem growth of gangs

Spurred on by the tragic death of a Cornelius youth, community members have been attempting to stem the growth of youth gangs by supporting families.

Familias Unidas (United Families) encourages and assists parents to take on the hard but rewarding responsibility of raising children at a time when pressures from gangs, drugs and violence seem all too accessible in the community.

At the same time, Familias Unidas has provided the children of the community with a forum that serves to bring adults out of their denial and lets parents and teachers know the nature of these struggles.

Sulma Escalona, 15, took the opportunity to address a community group at Centro Cultural in Cornelius that Familias Unidas organized. She was one of the panel of students that explained the racial pressures and gang presence a youth may face at school.

Escalona related the experience and repeated her message at a recent gathering of Familias Unidas organizers.

Although Escalona said gangs hold no attraction for her, she knows some kids aren't aware of what they may be getting themselves into once they join a gang.

"Some parents can't see why kids do it (get involved in gangs)," Escalona said. "Some parents just can't face their kids doing wrong."

At the same time, kids need to learn communication skills and ways of resisting peer pressure, Escalona explained.

Sometimes, there is little warning of impending tragedy these youths may face.

Miguel Angel Mendoza attended a wedding reception in January. A fistfight after the event left the 14-year-old dead of multiple stab wounds.

Rene Siller, 19, is awaiting a November trial date on one count of murder in the stabbing incident. He is held without (Continued on page 2A)

"We were brought together by the homicide of Miguel Angel," explained Arturo Peraza, one of the Familias Unidas organizers.

In the wake of the hopelessness following that homicide, Familias Unidas organized several community meetings that allowed participants to share their grief. Other meetings focus on ways to improve family communication and discipline.

The group has been active by painting over sites loaded with gang graffiti and cleaning up litter in Cornelius on Earth Day. Familias Unidas recently held a celebration in Hillsboro called The Day of the Family.

"It was a place where families could go and have a good time without having to spend money," said Kristin Ludwig of Familias Unidas.

Games were set up where kids could win a small prize. The Hillsboro Boys and Girls Club set up sports activities. And there was musical entertainment and raffles for adults.

Organizers were surprised but joyful that up to 2,000 people attended the event. No

gang related problems occurred at the event held at Shute Park.

Hillsboro Police Chief Ron Louie attended the event and saw that it fit in with the goals of the community.

"We help maintain the parks as a safe and fun place for families to be," Louie said. "The Day of the Family had exactly the image and environment that we want to project for the parks."

Familias Unidas considered the day to be the highlight of their work in the community to this point.

Instead of trying to duplicate or replace existing services available to families, Familias Unidas will try to link families to the resources they may need, Peraza said.

Other goals include: building leadership in the community; offering information regarding new laws; and providing parent

The prime goal of Familias Unidas is to give people hope, Peraza said.

In a sign that hope is growing in the community, many people, both young and old, came together to set up and run the many activities for the Day of the Family celebration.

Day of the Family celebrated locally

Six months after Washington County's first gang-related death, nearly 1,000 people gathered in Hillsboro's Shute Park: partly to remember the victims of gang violence, but mainly to celebrate the family and the positive influence it can have on young peoples' lives.

The event, called *Dia de la Familia* or Day of the Family, included a moment of silence to honor the victims of gang violence — particularly the young man who died earlier this year.


A variety of activities were available to catch the attention of almost every person in attendance. People of several different cultures joined in cooperative activities for an evening of family fun.

"We want to acknowledge the support and positive action from the community," said event organizer Kristin Ludwig. "That support creates a more peaceful and safe account to "

- Discussed ways to counteract gang influences, such as setting rules at home, effective discipline, and communication between youth and adults.
- Painted over 15 graffiti sites, with the cooperation of Washington County Juvenile Department and local home and business owners and using paint donated by the City of Cornelius and Neighborhood Watch.
- Organized with civic and youth groups an "Earth Day" litter clean up in Cornelius.
- Planned a "Day of the Family" in Hillsboro's Shute Park with activities for all ages, including games focusing on teamwork, to be held July 23.
- Supported parent groups in organizing a fundraiser activity to honor recent graduates of high schools in Hillsboro.




