## DIRECTOR'S COLUMN

I want to update you on recent program changes. As I mentioned at Wellness Day, I will continue to provide updates in this column, and encourage you to direct any question you might have to your manager or director. We are all committed to open communication and I have been especially encouraged by the open exchange of ideas from staff regarding our restructuring.

As a result of inadequate funding or grants not being renewed, the following changes have already been made:

- CAO no longer provides Tenant Education. Please refer tenant calls to Legal Aid Services of Oregon. They accept tenant calls on Mondays and Wednesdays from 9 a.m. to noon (648-7723). For emergencies such as evictions, clients can phone the direct line (648-7163).
- CAO will not be the lead agency for the IDA program. We are working with the Enterprise Foundation and our partners to find a new lead agency for the IDA project. CAO will make referrals once the program is operational.

As a result of staff work to create a first draft of a balanced budget, the following program changes are being made:

- As of May 1, CAO no longer offers I & R 24 hours a day. Clients can call the 648-0829 number and receive assistance Monday through Friday from 9 a.m. to noon and 1 p.m. to 4 p.m. We are discussing I & R with Community Partners to determine how I & R will be provided after July 1.
- CAO will not renew its ABC Soup contract and is working hard to find a new home for this program.
- Camp Eco (A Kid's Domain summer program) will not be offered this summer.
- CAO programs for homeless and housing services are being combined into one program. The Hillsboro shelter home staff has recommended a new staffing model that will result in restructuring current positions. In addition, the shelter home will be closed from May 20th through June 4th. Arrangements are being made for security checks and volunteer maintenance projects to occur at the shelter during the closure.
- Because of an influx of funding for energy assistance, CAO is shifting its emergency needs focus to energy assistance. Staff is still determining how food box referrals and rent assistance will be provided.
- As planned, CAO will hand over leadership of the Good Neighbor Center to the East Washington County Partnership Council on July 1.

In addition, the planning team (Jerralynn, Leon, Lowell, Marilyn, Renee, John and Sharon) is exploring various management models to support our organization's changes while reducing costs. This discussion will continue over the next week as we cost out these models to determine what is doable and affordable.

That's the latest. I'll keep you informed as we implement these changes. Again, please direct any questions to your manager.

## LOANS MADE EASIER, APRIL 2000

Oregon Housing and Community Services (OHCS) recently announced that it has increased the acquisition cost (purchase price) limits for its Residential Loan Program and can now help more first-time homebuyers purchase a home utilizing OHCS's below-market interest rate program.

The Residential Loan Program is designed to help eligible homebuyers increase their purchasing power by providing them access to below-market interest rates when financing their first home. The below-market rates are made possible through the sale of tax-exempt mortgage revenue bonds. To qualify for the program, a property's purchase price must be below the program's applicable limits. In Washington County, the new limit is \$152,125, as compared to an old limit of \$142,836, for an increase of \$9,289.

To be eligible for the program, a household's total annual income must not exceed \$45,100 statewide and \$52,400 for Benton, Clackamas, Columbia, Multnomah, Washington or Yamhill counties. Interested homebuyers should contact one of OHCS's participating lenders to see if they qualify.
