ANNUAL RECOGNITION DINNER -- BACKGROUND INFORMATION

OREGON HUMAN DEVELOPMENT CORPORATION'S Recognition Awards are the result of the Board of Directors wanting to give thanks to a particular individual or organization who has made outstanding contributions toward human development. It is a community event which honors individuals and groups who have worked to improve human services for members of ethnic minority groups, for women, and for other under-employed or unemployed people. It is also a social gathering for our Board of Directors, Industrial Board, Advisory Committees, staff members, representatives of our funding sources, colleagues in the employment and training field, and friends.

In the Awards Program, we are privileged to recognize the commitment, sacrifice, and hard work of community organizations and individuals who have taken the "extra step" to assist in the development of their fellow human beings. This work deserves public recognition, and OHDC is pleased to provide this Awards Programs as a forum for recognizing such honorable accomplishments.

Oregon Human Development Corporation is a private non-profit organization that is actively involved with providing a variety of services for economically disadvantaged individuals throughout the State of Oregon. The primary focus of OHDC is the provision of employment and training services for migrant and seasonal farmworkers who are seeking full-time non-seasonal employment in order to become economically self-sufficient. OHDC operates regional service offices in the following Oregon communities: Hillsboro, Woodburn, Klamath Falls, Hermiston and Ontario. In addition, OHDC has weatherization project offices in Hermiston, Woodburn, Ontario and Klamath Falls, a Hispanic Elderly Meals Program and Hispanic Access Program in Portland, a youth employment program in Hillsboro, and an alcohol treatment program in Hillsboro and it's administrative office located in Tigard.

Awards will be presented at the OHDC Eighth Annual Recognition Dinner on June 3, 1988, at the RED LION MOTOR INN, 909 N. Hayden Island Drive, Jantzen Beach, Portland, Oregon.

Nominations for the different awards are sent in by community members from throughout the State of Oregon. SELECTION OF AWARD RECIPIENTS IS MADE BY A SPECIAL COMMITTEE COMPRISED OF COMMUNITY LEADERS FROM VARIOUS PARTS OF THE STATE.

DESCRIPTION OF AWARDS

GOLDEN AZTEC AWARD

The Corporation's most coveted award for outstanding leadership and accomplishment in human development and human services. Nominee must have shown sustained commitment and leadership in causing major and broad-based changes in management and public attitudes toward women, the Spanish-speaking, or other minority groups in employment, training and development and maximum use of their skills, including enhancement of the quality of community life and culture. Only one Golden Aztec Award will be given.

Eligibility Criteria:

- 1. A person not associated by employment with OHDC.
- 2. A person who has caused major changes in management and public attitudes to benefit women, Spanish-speaking, or other minority persons in the areas of employment, training, development and maximum use of their skills.
- 3. A person who has, during the past 12 months, accomplished or caused accomplishment of a broad -based program in the areas described in Item 2 above.
- 4. A person who has, through the leadership activities described above, contributed toward enhancement of OHDC programs or is judged to be supportive of OHDC's goals (to operate for the advancement of education, improvement of the social conditions, and improvement of the job opportunities of low income, unemployed, and underemployed citizens of communities in which the Corporation shall function) on a continuing basis.

INDIVIDUAL AWARDS

Individual Awards go to community persons who have consistently and diligently given of themselves in volunteer community activities that contribute to more cohesive inter/cross-cultural relations and overall betterment of citizens in their community. Emphasis will be in human development and human services. Approximately six (6) awards will be given - representing all geographical areas in the State of Oregon.

Eligibility Criteria:

- 1. Nominee must be a resident of the area in which person making nomination resides and be within OHDC's service area.
- 2. Employees of OHDC may place names in nomination but are not eligible for nomination themselves.
- 3. A person who, during the past 12 months, has accomplished or caused accomplishment of a broad -based program in the areas described in the first paragraph of the Individual Awards section.
- 4. A person who has, through the leadership activities described above, contributed toward enhancement of OHDC programs or is judged to be supportive of OHDC goals (to operate for the advancement of education of the job opportunities for low income, un-employed and underemployed citizens of communities in which the Corporation shall function) on a continuing basis.

COMMUNITY ORGANIZATION AWARDS

Community Organization Awards are in recognition of accomplishments in human development and human services within the community or county they serve. Approximately six (6) awards will be given - representing all geographical areas of the State of Oregon.

Eligibility Criteria:

The organization nominated must:

- 1. Be located within the State of Oregon.
- Demonstrate effective coordination with other community groups.
- 3. Nomination of OHDC sub-contractors or program operators is disallowed.
- 4. Outstanding achievements (cite specific accomplishments and their impact on the community).
- 5. Be an organization serving minorities, low income and disadvantaged within its scope.
- 6. Demonstrate organizational leadership and advocacy for human development and services.

**NOTE: Selection of award recipients is made by a special committee comprised of community leaders from various parts of the state.
