"I know what it's like to be poor, homeless, and hungry. Working at Community Action is my way of giving back." Keith Byerly, Fiscal Operations Administrator, sees his work in finance and administration as supporting staff and therefore supporting clients. Keith sees his main responsibility as protecting the agency's assets, not only the money but also its buildings and clients from injury (insurance coverage, safety) and providing good customer service to clients and staff.

Since his arrival four years ago the agency's growth has translated into additional grants, additional children and services, and additional LIEAP money. In finance, more money means more checks going out and more payroll. As the agency's budget has increased, Keith's role has changed and he is highly complementary of his staff of skilled professionals who make it all happen.

Born and raised in the Bremerton area, Keith spent eight years in the Navy doing personnel work. His job consisted of processing discharges, transfers, and re-enlistments. During Desert Storm, he worked to recall reservists to duty, making arrangements for soldiers and their families and also processing them back to civilian life. While stationed on the USS Carl Vinson, Keith met his wife Emily while she was a guest on a Dependents' Day Cruise. Keith ended his naval career on Whidby Island when he and Emily decided to start a family. A dedicated family man, Keith and Emily decided to work different shifts so that their two

OOPS!

If you remember, at the Employee Handbook meetings I told you that the Handbook was a living document & continuously changing. Well, I've discovered something that should have been in it and was not included. It is an explanation of how the anniversary date changes if you were hired first in a temporary or casual on call position. If you were hired in this category, and later on moved to a status that allowed you to be eligible for benefits, your "anniversary" was changed to the date you became eligible for benefits. Therefore this is the date that is used for benefit changes and all other processes linked to your anniversary date. Example: You were hired 10-14-02 as a temporary employee. On 12-12-02 you went to a regular full time status (scheduled at 20+ hrs. per week). 12-12-02 is now your anniversary date. You would be eligible to add a dependent & be covered by the allowance for CAO to pay for that dependent premium on 12-12-03; and you become eligible to add an entire family & be covered by the allowance for CAO to pay for the family premium on 12-12-04.

You should also remember that because your anniversary date will fall within a pay period, we will make any changes effective with the beginning of the next pay period. If you find this confusing, please feel free to call me at ext. 257.

FMLA/OFLA: Staff is calling & leaving messages about taking this kind of leave. We cannot complete the process correctly with just a phone call. In order for this leave to be approved, & function correctly, you must meet with Human Resources.

Measure 28 - Jerralynn Ness

On January 28th, Oregon voters will be asked to vote or Ballot Measure 28. Community Action has been receiving some educational information on this ballot measure, which I would like to pass on to you.

Ogregon Center for Public Policy: "In House Bill 5100 of the fifth Special Session, the Legislature cut \$310 million across the board from state agencies, which will be rescinded if Measure 28 is enacted by the voters in the January 28, 2003 special election. \$88 million of those cuts come from the Department of Human services (DHS)."

Oregon Food Bank: "Measure 28 raises personal and corporate income taxes from 2002 through 2004. The top personal income tax bracket increases from 9.0% to 9.5%. Corporate tax rates increase from 6.6% to 6.93%. For less than \$9.50 per month for most Oregonians, we can preserve the most basic services and speed up our economic recovery. By passing the temporary income tax surcharge, Oregon voters will protect basic state services and keep the state open for business and able to attract new jobs."
