- · Keep your letter short and clear.
- Identify bills by title and number.
- Avoid threats. Be reasonable and constructive.
- State reason for your position. Tell how the issue would affect you, your business — or its effect upon your community or state.
- · Use your own words on your own stationery.
- If you are pleased with your legislator's vote, write and tell him or her so.
- Send copies to the Associated General Contractors so that the organization will have the benefit of your views.
