## FAMILY & COMMUNITÝ RESOURCES

2-1-1/I&R Q&A Series:

"What about 2-1-1 in the metro area?"

Historically, there have been four comprehensive I&R service providers in the four-county area (Clackamas, Clark, Multnomah, and Washington counties). Each of these organizations has provided information and referral services with their own database. During the fiscal year 2002-2003, the organizations purchased the same I&R software and have begun to merge the individual county databases. This process is slated to be complete by December 2003. In addition, a design was adopted which will result in the collaborative service delivery of 2-1-1 by the end of 2004. The design builds on the existing resources available and establishes a collaboration to deliver 2-1-1 in the region. One agency will act as the hub for call center activity in three of the four counties. Community Action will manage the four county database. Clackamas County Social Services will provide the quality assurance program for the collaborative program. Clark, Multnomah and Washington counties have merged databases as of September 2003. In addition, further private and public partnerships are being formed as opportunities for 2-1-1 deliver in the area.

## CHILDDEVELOPMENT

New recommendations from the American Academy of Pediatrics (AAP) were issued in early November regarding the use if "syrup of ipecac" for poison control. Parents and caregivers are asked to stop using ipecac for poison control because it is thought to be ineffective, can interfere with other poison control remedies, and poison control centers almost never use or suggest its use anymore. You are encouraged to discard any ipecac syrup that you may have in your home First Aid Kits in a safe manner, such as flushing it down the sink or toilet.

December 19<sup>th</sup> will be the last workday for Part Day, Part Year (Pre-K) program before they go on Winter Break for the week of Christmas & New Years. If eligible, you will receive Holiday pay for the 2 holidays. You may use accrued vacation hours for the other days you are off that week. If you are going to substitute at either Beaverton CDC or Hillsboro CDC, be sure a PAN is sent to HR so they are prepared to print timesheets, etc. Of course when you return to your regular schedule they need a PAN for that too.

## CHECKS& BALANCES

Fiscal - Payroll - It will soon be time to issue the W2's at the end of the calendar year. Take a minute to make sure to verify that we have your correct address. You do not have to call Payroll or HR to determine if we have the right info – just look at your last paycheck and if it isn't correct, complete a change of address form and send it in to HR. If we have the right info your W2 should get to you quickly. W2's are not mailed out until the end of January each year.

#### HR - Ask Winnie

Benefits, Diversity, Policy...?????

While no one has specifically requested information on the annual COLA in some time, I thought most of you would have an interest in this subject. As you may remember last July (when the COLA is normally paid to staff) the State of Oregon had not yet resolved the budget. And, we had already been notified of cuts in funding. Because we couldn't be sure of how much funding would be cut we postponed delivering a COLA increase until a time when we had a better understanding of which cuts would be made. Our crystal balls remain cloudy; however, we will implement a 1.5% COLA increase to salaries effective on the pay period beginning 11-23-03. This means you will see the increase on the pay check dated 12-12-03. Because we normally apply the COLA in July, we will pay each employee the 1.5% COLA for all hours paid between July 7, 2003 and November 22, 2003. This will be a separate check paid on 12-19-03.

Agency New Hire Orientations are being held at the main office every other Friday from 8:30 to 12:30. The next one is scheduled for December 19, 2003. If you are a new employee and haven't been to one of these, check with your supervisor to get scheduled to attend.
